ON 7/12/2020 AT APPROXIMATELY 1745 HOURS, I RESPONDED TO 600 LAYNE BLVD WITH REGARDS TO A CRIMINAL MISCHIEF REPORT. I MET WITH MAIRON BRANDWAJN (VICTIM) FROM WHOM I OBTAINED THE FOLLOWING INFORMATION.

BRANDWAJN STATED THAT HE PARKED HIS 2011 GRAY (4DR) HYUNDAI ELANTRA BEARING FLORIDA TAG:913TBK, VIN: 5NPDH4AE8BH054275 IN AN AVAILABLE PARKING SPACE. THEN, ON 6/03/2020 AT 0900 HOURS, HE MOVED HIS VEHICLE INTO HIS ASSIGNED PARKING SPACE #232. THE VEHICLE WAS IN GOOD CONDITION AND NOT DAMAGED.

ON 7/12/2020 AT APPROXIMATELY 1730 HOURS, BRANDWAJN NOTICED THAT AN UNKNOWN SUSPECT(S) HAD KEYED HIS VEHICLE ON BOTH SIDES FROM THE FRONT DOORS TO THE REAR QUARTER PANELS. ALSO, THERE WAS WHITE CHALKING PUT ON THE WINDOWS WHICH LOOKED LIKE AN ATTEMPT TO SEAL THEM. THE CHALKING WAS ALSO ON THE RIGHT FRONT SIDE OF THE WINDSHIELD.

THE FOUR TIRES WERE FLAT HOWEVER, IT DID NOT APPEAR THAT THERE WAS ANY INTENTIONAL DAMAGE DONE TO THEM.

THE ESTIMATED DAMAGE IS APPROXIMATELY \$1500.

THERE WERE NO KNOWN WITNESSES TO THIS CRIMINAL MISCHIEF AND NO SURVEILLANCE CAMERAS WERE SEEN IN THE IMMEDIATE AREA.

USING A DEPARTMENT ISSUED NIKON DIGITAL CAMERA, I PHOTOGRAPHED THE LISTED VEHICLE FROM SEVERAL ANGLES SHOWING THE DAMAGE.

THE MEDIA CARD (TS6) USED WAS PROPERLY SECURED AND DROPPED INTO THE EVIDENCE KEY SLOT AT HEADQUARTERS FOR PROCESSING.

BRANDWAJN WAS ISSUED A CASE CARD ALONG WITH INSTRUCTIONS ON HOW TO OBTAIN A COPY OF THIS REPORT.
