ON THIS DATE 7/28/2020 I WAS DISPATCHED TO 600 LAYNE BLVD APT 232 IN REFERENCE A BURGLARY IN PROGRESS. UPON A ARRIVAL VICTIM 1 "MYRON BRANDWIDE" WHOSE LEGAL NAME IS "BRANDWAJN, MAIRON JOSEPH ZELIG" WAS SITTING ON THE FLOOR BY THE DOOR WITH A HEAD INSURY AND BLOOD DRIPPING FROM HIS RIGHT EYEBROW.THE DOOR TO THE RESIDENCE WAS OPEN. I ENTERED THE VICTIMS RESIDENCE AND MADE CONTACT WITH VICTIM 2 "DANE ADRIAN MAURICE SMITH".

AS PER VICTIM 1;

HE WAS IN THE RESIDENCE WHEN HE HEARD NOISES OUTSIDE OF HIS HOUSE. HE OPENED THE FRONT DOOR AND THE SUSPECT, IDENTIFIED BY VICTIM 1 AS "JUSTIN DINKS" WAS STANDING OUTSIDE OF THE RESIDECE WITH A METAL PIPE. THE SUSPECT BEGAN TO STRIKE THE VICTIM AS V1 ATTEMPTED TO CLOSE THE DOOR. V1 WAS STRUCK ON THE HEAD/ FACE AREA NUMEROUS TIMES BY THE SUSPECT S WITH THE METAL PIPE. V1 FELL TO THE GROUND AND THE SUSPECT CONTINIUED TO STRIKE HIM. V1 TRIED TO USE HIS ARMS AS A SHIELD AND THE VICTIMS PHONE FELL TO THE GROUND DURING THE STRUGLE . VIC 1 YELLED "STOP, PLEASE STOP" AS THE SUSPECT YELLED "DONT FUCKING PLAY WITH ME" AS HE STRUCK HIM AND STOOD OVER HIM.

AS PER VICTIM 2:

HE WAS ON A FACETIME CALL WITH HIS THERAPIST. HE HEARD THE DOG BARKING AND V1 SCREAMING. HE OPENED THE DOOR TO THE LIVING ROOM AND SAW THE SUSPECT STANDING OVER V1 HITTING HIM AND SCREAMING "DONT FUCKING PLAY WITH ME" V2 ATTEMPTED TO STEP IN AND HE WAS STRUCK ON THE RIGHT HAND BY THE PIPE WHICH CAUSED A LACERATION. THE SUSPECT GRABBED V1 PHONE AND THREW IT AT THE LIVING ROOM TABLE SHATTERING THE TOP GLASS OF THE TABLE. HE WALKED UP TO THE TV AND INTO THREW INTO THE GROUND SHATTERING THE SCREEN.HE BEGAN STRIKING OTHER ITEMS ATTEMPTING TO BREAK THEM. A NEIGHBOR WHICH PREFERS TO REMAIN ANONYMOUS WALKED UP TO THE DOOR OF THE APARTMENT AND TOLD THE SUSPECT "YOU SHOULD LEAVE" THIS SCARED OFF THE SUSPECT AWAY AND HE FLED.

CSA CLARKE RESPONDED TO THE SCENE AND TOOK PICTURES OF THE SCENE. SEE HER SUPPLEMENT FOR MORE INFORMATION.

HALLANDALE RESCUE RESPONDED TO THE SCENE AND BOTH VICTIMS WERE TRANSPORTED TO AVENTURA HOSPITAL FOR TREATMENT.
