ON AUGUST 13, 2020 AT APPROXIMATELY 1515 HOURS, I RESPONDED TO 600 LAYNE BLVD #207 IN REGARDS TO AN INFORMATION REPORT. UPON ARRIVAL, I MADE CONTACT WITH LORENNYS RODRIGUEZ AND HER MOTHER, ROSANA GONZALEZ. LORENNYS STATED THAT HER NEIGHBOR, MYRON BRANDWINE HAD BEEN HARASSING THEM ON MULTIPLE OCCASIONS.

ON JULY 25, 2020 AT APPROXIMATELY 1100 HOURS, MYRON BANGED ON THE BACK DOOR OF THE APARTMENT. AS SOON AS LORENNY`S OPENED THE DOOR, MYRON BEGAN YELLING AT HER AND ROSANA. ROSANA AND LORENNY`S IMMEDIATELY SHUT THE DOOR, AT WHICH TIME MYRON BEGAN PULLING FORCEFULLY ON THE HANDLE TO TRY AND GAIN ENTRY. MYRON ALSO WAS BANGING LOUDLY ON THE DOOR. LORENNY`S AND ROSANA STATED THEY WERE IN FEAR FOR THEIR SAFETY. DUE TO THE TIME DELAY NO FINGERPRINTS OF THE DOOR WERE TAKEN. IF POSSIBLE LORENNY`S AND ROSANA WOULD LIKE TO PURSUE CRIMINAL CHARGES AGAINST MYRON.

ON AUGUST 11, 2020 MYRON APPROACHED ROSANA WHO EXITS HER RESIDENCE IN THE OPPOSITE DIRECTION OF WHERE MYRON RESIDES. MYRON TURNED TO ROSANA AND BEGAN CHASING HER IN AN AGGRESSIVE MANNER WHILE SAYING "I WILL GET YOU" AS HE IS SIMULTANEOUSLY TAKING PICTURES AND VIDEOS OF HER. LORENNY`S HEARD THE COMMOTION AND EXITED THE APARTMENT AT WHICH TIME MYRON BEGAN DOING THE SAME THING TO HER. LORENNY`S STATED MYRON APPROACHES THEM IN THE REAR OF THE BUILDING BECAUSE HE KNOWS THERE ARE NO CAMERAS THERE SINCE HE IS THE ONE WHO CONTROLS THEM AS A REPRESENTATIVE OF THE BUILDING. LORENNY`S WAS GIVEN INFORMATION ON OBTAINING A RESTRAINING ORDER. THERE IS NO FURTHER INFORMATION TO REPORT AT THIS TIME.
