THOMAS-FORD, SHADEEM	SEXUAL BATTERY

ON SEPTEMBER 6, 2018, I WAS DISPATCHED TO 3101 SE 6TH AVENUE, APT 5, IN FORT LAUDERDALE IN REFERENCE TO A SEXUAL BATTERY. UPON ARRIVAL, I MET WITH VICTIM SHADEEM THOMAS-FORD AND FLPD OFFICER BRIGNONI (BADGE 1432) WHO RELAYED TO ME WHAT THE VICTIM HAD REPORTED TO HER. THE VICTIM SAID HE WAS MERELY VISITING FRIENDS STAYING AT THE MOTEL AT THIS ADDRESS, AND GENERALLY STAYS AT LEGACY HEALING CENTER IN MARGATE IN REFERENCE TO SUBSTANCE ABUSE.

ACCORDING TO THE VICTIM, HE MET THE SUBJECT ONLINE AT GRINDER.COM. THE SUBJECT, KNOWN TO THE VICTIM MERELY AS ANTHONY (GRINDER ALIAS "AHOEIOORGAHG"), WAS DESCRIBED AS A W/M, LATE 20s, 5-10/11, MUSCULAR, BUZZ CUT BROWN HAIR, CLEAN SHAVEN, WITH A TATTOO ON THE CENTER OF HIS CHEST AND ANOTHER ON THE SIDE OF HIS TORSO.

THIS MORNING AT APPROXIMATELY 0325 HOURS, ANTHONY PICKED-UP THE VICTIM IN AN UBER AT THIS ADDRESS. THE UBER CAR WAS DESCRIBED AS A BLACK DODGE CARAVAN. THE TWO RODE BACK TO WHAT THE VICTIM BELIEVES TO HAVE BEEN ANTHONY'S APARTMENT AT 600 LAYNE BOULEVARD #232. EN ROUTE, THE TWO SHARED PAST EXPERIENCES OF ABUSE.

THE ENCOUNTER BEGAN WITH CONVERSATION FOLLOWED BY CONSENSUAL ORAL SEX. WHEN IT BECAME ROUGH, THE VICTIM TOLD THE SUBJECT TO STOP, EVENTUALLY HAVING TO KICK THE SUBJECT IN THE CHEST. THE SUBJECT STRUCK THE VICTIM SEVERAL TIMES WITH AN OPEN HAND, INCLUDING TO THE FACE AND TORSO. THE SUBJECT FORCIBLY ENTERED WITH HIS PENIS THE SUBJECT ANALLY, REPEATEDLY, AGAINST THE VICTIM'S WILL. THE SUBJECT THEN DEFECATED AND URINATED ON THE VICTIM'S CHEST AGAINST THE VICTIM'S WILL.

THE VICTIM SAID THAT SOON AFTER HE ARRIVED AT ANTHONY'S, HE WAS GIVEN WHAT ANTHONY SAID WAS METH. LATER HE NOTICED THAT HIS INSULIN MEDICATION HAD GONE MISSING. HE FOUND HIS CELL PHONE HIDDEN IN A KITCHEN DRAWER.

HE FLED FROM THE APARTMENT AND TOLD A BLONDE W/F SECOND-FLOOR NEIGHBOR IN HER 40s THAT HE NEEDED HELP. THE NEIGHBOR CALLED FOR AN UBER WHICH BROUGHT THE VICTIM BACK TO THE MOTEL, ARRIVING AT ABOUT 0915 HOURS. THE CAR WAS DESCRIBED AS NEWER MODEL GREEN NISSAN ROGUE, DRIVEN BY A B/M IN HIS 50s.

THE VICTIM SAYS HE WOULD RECOGNIZE THE SUBJECT AND WOULD PRESS CHARGES. HE SAYS HE HAS PICTURES OF THE SUBJECT FROM THE GRINDER WEBSITE.

FLFR TRANSPORTED THE VICTIM TO BROWARD GENERAL HOSPITAL IN REFERENCE TO ELEVATED BLOOD SUGAR DUE TO DIABETES AND ELEVATED VITAL SIGNS. SOME HOURS LATER, THE VICTIM INDICATED HE WANTED TO LEAVE AGAINST MEDICAL ADVICE PROMPTING A HOSPITAL STAFF DOCTOR TO BAKER-ACT HIM.

DETECTIVE GRIECO ARRIVED TO TAKE THE VICTIM'S STATEMENT.

USING PICTURES PROVIDED BY DETECTIVE GRIECO, I ADMINISTERED A SIX-PHOTO LINE-UP FOR THE VICTIM WHO SAID HE WAS UNABLE TO CONCLUSIVELY IDENTIFY THE SUBJECT FROM AMONG THOSE DEPICTED.
